## A. Introduction

1. The meeting was called to order by R. Green at 3:32 PM.

- 2. W. Bullock confirmed that public notice of the council meeting was given, as required by open meetings law.
- 3. Quorum. Of the eight council members, seven were present. Council operating policies require greater than 50%, so the number of quorum was met.

## B. Council Business

Motion to Enter Closed Session: At 3:34 PM, R.
