## A. Introduction

- 1. Call to Order. W. Bullock called the meeting to order at 2:00 p.m.
- 2. Quorum. Per KEEC operating policies, the members of the committee present at any meeting of that committee shall constitute a quorum for transaction of business.
- 3. Action: Motion to approve January 23, 2024, ISEE Meeting Minutes: At 2:06 PM, R. Burnes moved to approve the minutes of the January 23, 2024, ISEE Meeting. C. Weidamann seconded. All were in favor. None were opposed. The motion passed.

## B. Agency Introductions

- 1. E. Hogue and C. Rogers reported on the environmental education-related initiatives that their agencies are conducting, have planned, or would like to plan.
- 2. New EE initiatives. K. McDonald asked for input on an online volunteer hub for state agencies and non-profit organizations. A. Mike offered to provide information about the existing volunteer hub hosted by Serve KY.

#### C. Possible collaborations

State agency EE training. W. Bullock asked the committee about their agencies' potential
interest in a one-day state agency environmental education training to be held in Frankfort. E.
Hogue said her department would have lots of folks who interact with the public, and she would
want to talk with them about their needs for a training. C. Weidamann had planned to do a
Project Learning Tree training. C. Rogers would want some of her coordinators to participate. R.
Burnes said she had 3-5 folks that might be interested because it's something that they love
doing. K. McDonald said that it would be beneficial for biologists in her agency. M. Lambert said

- that basin coordinators planned to attend the full Professional Environmental Educator Certification course, but others could from a one-day training. Committee consensus was that January 2025 would work best as a target date. E. Hogue proposed trainings in other parts of the state as a follow-up.
- 2. Earth Day 2025. W. Bullock proposed a "Green Careers" focus across state agencies for Earth Day 2025. K. Delamarter offered to help because it aligns with what she does on a daily basis, but noted that the hard part is making sure that the material reaches its target audience. Committee members asked for something that combined everyone's info for all to post. R. Burnes noted that another state has a state-sponsored green career mentorship portal.
- 3. New ideas. R. Burnes proposed a directory of state agency folks who can go to schools for outreach requests.
