The Morgan County School district has become the first in Kentucky to have 100% of its schools pledge participation in KGHS. By including students, district and school staff, and the local community in their Green Team, the 6 schools are making big strides toward their goals of increased energy efficiency and sustainability.

Frances Gulley, the Green Team leader and gifted and talented teacher for the district, Linda Rose, a PRIDE liaison, and Lisa Hoskins, an Americorps employee, are working with 4<sup>th</sup> and 5<sup>th</sup> grade students from the 4 elementary schools.

The students are in the process of completing KGHS inventories and projects in both the solid waste and energy categories. "Our elementary students approach our custodians with clipboard and pencils in hand to get answers for the energy inventories," said Gulley. "They are learning math skills by calculating the cost of energy per stu-

dent based on the answers they get." The students and staff have also started a recycling program in each of the elementary schools.

While the elementary students have focused on recycling and gathering information about energy usage in the schools, the school and district staff have begun work on energy efficiency improvements. Darren Sparkman, the facilities director for the district, has created a friendly competition between the 6 schools to encourage energy savings by posting energy usage charts in each school. Even the school board office is participating—each light switch in the building has been labeled with an employee's name, and it is that employee's responsibility to ensure lights are turned off in rooms that are not being used.

By including individuals with many different roles within the schools, the district has formed a highly effective team and has created cost-saving behavior change in both students and staff.

Work began with the elementary schools, but "We plan to keep going, and to start working on KGHS inventories with the middle and high school soon," Gulley said of the district's future plans.

Students at the Montessori Middle School of Kentucky have started off the 2010-2011 school year by studying sustainable living. In doing so, they have completed both the water and indoor air quality inventories this year, and have reviewed their previously completed energy, transportation and green spaces inventories.

The students have initiated a number of projects in the water and green spaces categories,

moving them closer toward their goal of reaching Official Green and Healthy School status.

For the water category, students have designed a rainwater collection system and have applied for a KGHS grant to fund the project. The collected water will be used (instead of treated water) to irrigate the outdoor classroom area. Students have also installed a rain gauge in preparation for a spring semester

Stream and Aquatic Life Study. The focus of this study will be to structurally improve the stream that bisects the school property.

The school has been recommended to receive an LFUCG grant to pay for the construction and monitoring of this project.

In the green spaces category, the students have established a system of monitoring and providing

care for the school chickens on weekends and during vacations. Students and staff plan to begin using the eggs from the chickens as soon as they start producing.

The work doesn't stop there. In the school garden area, plans have been made to start an asparagus garden. The students are pictured (page 1) planting other cold weather crops in the school's raised beds.

# Kentucky Environmental Literacy Plan (KELP)

A Task Force appointed by Kentucky Department of Education Commissioner Terry Holliday is developing an Environmental Literacy Plan for Kentucky (KELP). In partnerships with KDE, the Kentucky Environmental Education Council and several other environmental education organizations are drafting the plan. The working group intends to present a draft of Kentucky's Environmental Literacy Plan to the full Task Force by early Summer, 2011. When the Environmental Literacy Plan is complete, the Kentucky Department of Education will become eligible to apply for funding that is expected to be made available through the No Child Left Inside Act (NCLI). NCLI is a proposed amendment to the Elementary and Secondary Education Act. If passed, the act would provide funding for teacher professional development in environmental education. The Environmental Literacy Plan will outline how Kentucky will ensure that all citizens will have an understanding of environmental information, concepts, and processes.

The working group has also created the Kentucky Environmental Literacy Alliance (KELA), a coalition that businesses, individuals, and organizations can join to show their support for expanding environmental literacy in Kentucky.

The KELP working group is soliciting feedback from teachers and school administrators. The information gained from the surveys below will help the KELP working group create a more effective plan. To take the surveys, simply click on the links.

## New KEEC Executive Director

KGHS is pleased to announce that its parent agency, the Kentucky Environmental Education Council (KEEC), has a new Executive Director. Elizabeth Schmitz was appointed in September 2010 after Jane Eller (Director of the agency for 16 years) retired.

Elizabeth has 10 years of experience as a non-formal environmental educator. Previous to taking her new position at KEEC, she served first as an Environmental Education Specialist, then as an Internal Policy

Analyst III for the Kentucky Division for Air Quality. Elizabeth also served on the Kentucky Association for Environmental Education's Board of Directors for four years and is a pastpresident of KAEE.

"I'm looking forward to helping teachers, administrators and families get children outside to learn and play, a strategy shown to increase student engagement and creative problem solving skills," Elizabeth said. "The environment is an engaging context for learning because

children can relate best to what they are familiar with, to what they can find in their own schoolyards," she said.

KEEC, located within the education cabinet, provides environmental education resources to Kentucky citizens, teachers, organization and businesses. The agency produces several publications, including a Master Plan for Environmental Education, research on Kentuckians' environmental literacy, and lesson plans that are free to download.
