KGHS teachers, try the new forms for Energy and Green Spaces

During the 2014-15 school year, the KGHS program, in partnership with KY NEED, began piloting new category forms in Energy and Green Spaces. The new forms are user editable PDFs so teachers and students can easily enter information and save their work. The questions in the forms have been reviewed by the KGHS Advisory Committee and specialists in energy and green spaces to bring the science up to date. In addition, at the request of teachers participating in the KGHS program, categories are now broken out into grade bands: K-5, 6-8, and 9-12.

The steps in the KGHS program have changed with these new forms. Rather than submitting the Investigation, Proposal, and Report, Green Teams complete and submit the new category forms and then move directly on to their Improvement Project without needing to complete a new Proposal form. Teams still need to complete a final Report when they have completed their projects.
